## **U.S. Figure Skating/Skating Club of Phoenix Waiver and Release and Assumption of Risk Agreement**

In consideration of me being permitted to participate in any way in the **U.S. FIGURE SKATING AND CLUB OR SKATING CLUB OF PHOENIX** sponsored Activities (“Activity”), I agree:

1. I understand the nature of **U.S. FIGURE SKATING AND SKATING CLUB OF PHOENIX** activities and believe I am qualified to participate in such Activity. I further acknowledge that I am aware the activity will be conducted in facilities open to the public during the Activity. I further agree and warrant that if at any time I believe conditions to be unsafe, I will immediately discontinue further participation in the Activity.
2. I FULLY UNDERSTAND that: (a) **U.S. FIGURE SKATING AND SKATING CLUB OF PHOENIX** Activities involve risks and dangers of **SERIOUS BODILY INJURY, INCLUDING PERMANENT DISABILITY, PARALYSIS AND DEATH** (“Risks”); (b) these Risks and dangers may be caused by my own actions, or inaction’s, the actions or inaction’s of others participating in the Activity, the condition in which the Activity takes place, or **THE NEGLIGENCE OF THE “RELEASEES” NAMED BELOW**; (c) there may be other risks and social and economic losses either not known to me or not readily foreseeable at this time; and **I FULLY ACCEPT AND ASSUME ALL SUCH RISKS AND ALL RESPONSIBILITY FOR LOSSES, COSTS, AND DAMAGES** incurred as a result of my Participation in the Activity.
